On May 31, 2017, radiology and transcription reports from St. Joseph's Healthcare Hamilton (SJHH) are being sent to Health Report Manager (HRM) subscribers. This data is being sent via existing data integrations from the hospital to HRM, via ClinicalConnect. Physicians who subscribe to HRM can now receive their patient's SJHH reports electronically in their EMRs, in addition to reports from all those existing sending facilities from across Ontario - click here to see the names of organizations that send data to EMRs via HRM.

ClinicalConnect Participation Agreement Framework Update

On Wednesday, July 5, the ClinicalConnect Participation Agreement will go into effect, replacing the current Data Sharing Agreement. Starting July 5, upon next login, all users will be prompted to accept the new ClinicalConnect User Agreement to continue their access to the portal.

The deployment of the ClinicalConnect Participation Agreement and associated framework has been a significant undertaking, with hundreds of existing Participant organizations and thousands of physicians who use ClinicalConnect contacted to complete their Participation Agreement based on their clinical practice and needs.

Almost all Participant organizations have submitted the Participation Agreement, and more than 800 physicians have submitted a Participation Agreement to access ClinicalConnect as a Sole Practitioner Health Information Custodian, instead of, or in addition to, accessing ClinicalConnect under the authority of another Participant organization.

Together with the cSWO Delivery Partner teams, we will continue to work past the July 5 Agreement Effective Date to onboard additional Sole Practitioners, and other new healthcare organizations as part of our regular engagement and adoption activities.

Thank you to everyone, particularly our cSWO Delivery Partner teams, for their assistance in helping to successfully complete this important milestone.

New User Functionality in ClinicalConnect: UAO Selector

On July 5, Local Registration Authorities will be able to provision a user who is a regulated health service provider to access ClinicalConnect as Agents of more than one Participant organization, using one set of login credentials. These users will be prompted with an "Under Authority Of" (UAO) Selector upon logging into the portal, and can then select which organization they are currently accessing patients' PHI on behalf of and will have the ability to easily toggle between organizations they are authorized by to view PHI as appropriate.
