New Features Launched on August 15 th, 2020!

We are excited to announce the newest release of ClinicalConnect, referred to as version 5.1, which offers three important new features designed to continuously optimize the user experience.

- 1. A new Preference Setup Wizard: This Wizard steps users through how to set the values associated with how they prefer to retrieve and view data in ClinicalConnect. Users can select different options for desktop and mobile devices, as well as when using the portal's Patient Dashboard. Preferences only need to be set and saved once, and will be retained for all subsequent uses. Should preferences need to be changed in the future, use the Preferences option within each module and Census List, or return to the Wizard anytime you are logged into ClinicalConnect by clicking on your name in the top right corner of the screen and selecting 'Preference Setup Wizard'. It is important that all users take a moment to review the new preference setting options available in version 5.1 to ensure selected preferences will best optimize access to their patients' health records and facilitate the default display of desired patient data especially in the dashboard and mobile views.
- 2. Rolled-up Search Results: When using ClinicalConnect's Simple Search functionality on desktop devices, patient search results now display in a rolled-up list view if the patient has visits at multiple facilities across Ontario, making the search results list shorter and more efficient. The search results will roll up the patient's encounters only when there is an exact match of the patient's Last Name, Date of Birth and Health Card Number across all encounters. If there is a mismatch in any of the three matching criteria, the patient's non-matching record(s) will not roll up and will remain listed as separate line items. The rolled-up search results will display the most recent encounter from the source facility as the first line item.
- 3. Email Notifications when patients have new results available in ClinicalConnect: ClinicalConnect users (initially at Hamilton Health Sciences, with broader deployment to follow) will be able to subscribe to receive notifications by email when new results become available in select modules in their patients' record. This notification functionality is built on the existing New Results module which aggregates new results from direct data integrations with select acute care hospitals in south west Ontario; provincial repository data does not currently support the New Results/Notifications feature. No Personal Health Information (PHI) or Personal Information (PI) is included in the email itself. Further information regarding this feature and its enablement will be communicated separately.

Gaining Access to Provincial Repositories Through ClinicalConnect™

Many Sole Practitioners (physicians) and Participant Organizations have benefited greatly by having access to the Provincial Repositories through ClinicalConnect. If you haven't yet initiated the process, we would encourage you to do so, so you too can expand your access to patient information.

If you or your organization has the provincial repositories enabled, ensure you have set your Preferences to "All Regional Encounters". This can be completed in Step 1 of the new Preference Setup Wizard released earlier in August.

If you don't yet have access, but are interested in completing the necessary requirements, we have included information to help you determine what steps are required to gain access:

Otherwise, please your Legal Signing Authority can email us at Agreements@ ClinicalConnect.ca to let us know you'd like to proceed, or if you have any further questions about these requirements.

*The Ministry of Health and Ontario Health (Digital Services) determine which HIC types are

eligible to view data from provincial repositories, using ClinicalConnect. If your organization is not currently eligible but you would like to submit to have your eligibility reviewed, please contact us and we can assist you with initiating the request.

Coming Soon – New SWO Data Contributors to acCDR & OLIS

Across the province work continues to expand the data available within the provincial repositories. Specifically within south west Ontario, we are getting one step closer to having Transcription and Radiology reports from Brant Community Healthcare System and Joseph Brant Hospital sent to the Acute & Community Clinical Data Repository (acCDR), leveraging those hospitals' existing data integrations with ClinicalConnect. The teams have been hard at work configuring these changes, with initial test data now being sent to our pre-production environment. With this significant milestone complete, we are optimistic for an early Fall go-live, where authorized users from across the province will be able to view this data in the acCDR.

Similarly, our work continues with Ontario Health (Digital Services) and Joseph Brant Hospital to contribute their Lab reports to Ontario Laboratories Information System (OLIS). In July, COVID-19 data reported by Joseph Brant Hospital was made available in OLIS, and now we are looking forward to building on that work and having additional lab data from this hospital sent to OLIS starting later this fall. Our thanks to the project team at Joseph Brant for their efforts in moving this forward.
