# ClinicalConnect Integrated with Cerner at Grand River Hospital & St. Mary's General Hospital

Earlier this month, we completed the second phase to integrate the new Cerner Hospital Information System, used at both Grand River Hospital (GRH) and St. Mary's General Hospital (SMGH) in WW LHIN, with ClinicalConnect.

#### ClinicalConnect Now Sending Niagara Health's Lab Test Results to OLIS

We're pleased to advise that various lab tests, reported from Niagara Health, are now being sent into the Ontario Laboratories Information System (OLIS), via ClinicalConnect, the regional clinical viewer for south west Ontario.

OLIS is an information system operated by eHealth Ontario that is used as a tool to maintain a comprehensive lab test history for patients. OLIS further enables the delivery of quality care for patients by helping to secure the electronic exchange of laboratory test orders and results.

Data collected as part of routine and specialized testing ordered at all Niagara Health sites, as listed below, is being sent to OLIS. This addition complements other hospital lab, community lab and public health lab data OLIS has in its repository:

- Blood Bank
- Labs (including Chemistry, Hematology, Coagulation and Immunology)
- Microbiology
- Pathology

It is important to note that this project does not affect how authorized physicians and clinicians use ClinicalConnect to view data for their patients.

ClinicalConnect is already being leveraged to send lab data from Hamilton Health Sciences and Brant Community Healthcare System to OLIS such that it can be viewed by healthcare providers across Ontario that are authorized to access that repository.

Thank you to our colleagues at Niagara Health for their work to complete this outbound integration from ClinicalConnect to OLIS.

#### **Semi-Annual Attestations Almost Complete**

The semi-annual attestation process for Participant Organizations began on November 1, and attestations are close to being completed. Thank you to all the Participant Organizations that completed their requirements early on in the attestation cycle.
