Did you know ClinicalConnect can be leveraged to seek supporting documentation for eConsult?

eConsult is a secure web-based service, hosted on OTNHub, that allows primary care providers to seek advice from specialists about their patients' care. As all eConsults should contain relevant and patient-specific information in sufficient detail for the specialist to provide advice, primary care providers can search for their patients' relevant reports in ClinicalConnect, download reports as PDFs, and attach to their eConsult.

Specialists who answer eConsults also have the ability to use ClinicalConnect to look up recent hospital transcription reports, labs, diagnostic imaging or other reports to assist with providing patient-specific and detailed advice.

Case Example

A primary care provider is concerned about their patient who is looking slightly jaundice. After sending the patient for liver function tests at their local lab, the primary care provider uses ClinicalConnect to download the patients' AST and ALT reports as a PDF document and attaches the report to their eConsult to a local gastroenterologist.

After the gastroenterologist reviews the liver function tests, it is determined that the patient should be referred to the gastroenterology clinic. Subsequent tests reveal a possible GI malignancy. The patient is sent for surgery and is now disease-free.
